### **Program Plan**

24-month successful completion of the RESET Program. Early termination will be recommended to the sentencing judicial officer.

### **Participant Responsibilities**

1. Compliance with all mandatory, standard, and special conditions of supervision.
2. Attend all court sessions and hearings.
3. Provide truthful and complete information to the probation officer and the Court about obstacles to success and assist in determining solutions/goals.
4. Encourage attendance of his/her family, employers, treatment providers, and significant others to each court session.
5. Accept rewards given by the RESET Program and comply with sanctions imposed by the Court or probation officer.
6. Give full effort to achieve goals set by him/herself and the RESET Program Team.

### **U.S. Probation Officer Responsibilities**

1. Ensure supervision conforms to the RESET Program policies.
2. Monitor participant's performance and timely report all progress and noncompliance to the RESET Program Team.
3. Develop communication link with resources and facilitate referrals.
4. Encourage attendance of participant's family, employers, treatment providers, and significant others to each court session.
5. Make recommendations commensurate with the RESET Program mission.
6. Implement sanctions and rewards ordered by the Court.
7. Facilitate recommendation of early termination to the sentencing judicial officer when program goals have been achieved.

### **Assistant U.S. Attorney**

1. Provide recommendations to the Court regarding dispositions commensurate with the mission of the program.

1. Provide recommendations to the Court commensurate with the mission of the program and the best interest of the participant.
2. Assist the participant with identifying goals that are important to the participant.

### **Sanctions**

The RESET Program seeks to deal with technical violations of the conditions of supervision without revocation through sanctions and support. Upon a violation of the terms of the RESET Program, it is understood that the judicial officer may impose any of the sanctions:

1. No credit given toward 52-week program total for any period in which performance is unsatisfactory.
2. Judicial reprimand
3. Curfew
4. Increased reporting
5. Geographic and association restrictions
6. Community service requirement
7. Location monitoring
8. Public law placement at the Residential Reentry Center
9. Custodial period
10. Referral to District Court for revocation of supervision, which could include suspension of the program and imprisonment.
11. The Court reserves the right to impose any other sanctions as the judicial officer sees fit.

### **Rewards**

Each RESET Program participant who has a successful month of supervision will be credited for four weeks of the 52 weeks to complete Phase One, and eventually Phase Two. Once the participant has accumulated a total of 52 weeks credit, under Phase One, the participant will receive a certificate. Upon receiving an additional 52 weeks' credit, under Phase Two, the participant will receive a graduation certificate with successful completion of the program. The RESET Program Team members will provide a recommendation to the sentencing judicial officer for a reduction of at least twelve (12) months of supervised release.
